This test utilizes samples of hair, blood, and urine to assess mercury forms and levels and the body's elimination capabilities. It helps practitioners and patients understand the magnitude and source of mercury exposure, as well as if insert detoxification after additional support is needed.

Quicksilver Scientific's Mercury Tri-Test is the only clinical test available that utilizes mercury speciation analysis, a patented advanced technology that differentiates methyl mercury (MeHg) from inorganic mercury (HgII) and measures each directly. It helps assess the need to reduce fish consumption and/or consider dental amalgam removal. Quicksilver Scientific's testing

instruments are sensitive enough to measure ambient mercury levels in the body without the need for challenge testing. Our laboratory test provides unprecedented information for health-care practitioners, allowing them to assess their patient's exposure sources, body burden, and ability to excrete each form of mercury. This detailed information helps build an informed picture and allows the clinician to plan a rational approach to a successful detoxification strategy for the patient.

Note on Challenge Testing:

The Mercury Tri-Test is a safe way to assess mercury levels without the need for provocation. Challenge testing provides an incomplete picture of the body's burden of mercury and may even be harmful, redistributing mercury to sensitive tissues and organs.

Metals Panel screens for a broad
range of potentially toxic and
nutrient metals to show elevated
exposure to toxic metals or imbalances of nutrient metals in whole
blood. Results from this test can be
used as a standalone screening, or
to enhance information obtained
from the Mercury Tri-Test. Because
different protocols or support may
be indicated to balance the other

potentially toxic and nutrient elements in the blood, the most effective detoxification protocol can then be selected by a practitioner. This whole-blood elemental metals analysis uses state-of-theart inductively coupled plasma/mass spectroscopy. The test measures levels for 16 metals, including beneficial nutrient metals and potentially toxic metals.
